

#### **Dubai Financial Market**

**DFM General Index <.DFMGI> closed at 2,482.66 point.** The cross over last September high at around 2,320 point is a positive sign along with the close above all MAs on the weekly chart, which should then open the road for further strength towards 2,585 point before 2,760 point. On the counter side, back below the first defense line at 2,390 point would bring back to focus 2,320 point, while a break below it will trigger 2,140 point.

Medium-term and long-term investors can stay in the market but should watch out if the index closes below 2,320 point.

**Price closed at AED10.900.** The stock continues to move within the ascending trend line and over all MAs on the weekly chart but still needs to surpass the resistance level at AED11.400 to confirm a positive continuation pattern and call for an advance to the strong layer at AED13.930. However, a fall below AED9.300 would increase the downside risk and lead to further correction to AED7.800.

# **Dubai Islamic Bank**

**Price closed at AED4.540.** The stock still shows promise for additional gains and currently encounters a resistance level at AED4.660, knowing that a close above this should be enough to anticipate a gradual jump to AED5.240. On the counter side, the nearby support levels are located at AED4.250 and AED4.000, while only a dip below AED4.000 will delay any upward momentum and trigger AED3.750.

# **Shuaa Capital**

Reuters Ticker: <SHUA.DU>

**Price closed at AED0.637.** The stock has been trapped between the range of AED0.575-AED0.740 for the last 4-months, without any clear signal as to where it could go from here. A cross over AED0.740 will re-activate the buying momentum and allow another jump to AED0.890 before the strong layer AED1.050. However, a fall below AED0.740 will most likely lead to AED0.500 and maybe lower to this year low at AED0.397.



Air Arabia Reuters Ticker: <AIRA.DU>

**Price closed at AED1.280.** The current technical picture is positive and the jump over the 50% level of the Fibonacci Retracements from AED1.610-AED0.867 at AED1.240 should attract additional gains towards the next target price at AED1.330 (61.8% level) and maybe higher to AED1.450. On the negative side, the support level at AED1.200 should prevent a drop to the strong line at AED1.070 but only below this will accelerate the bearish tone.

Technical Analysis 3

### **Definitions**

**Technical Analysis:** Aims to identify the direction of prices and reveal any indication of possible changes as soon as possible, so it can be used as much as possible in making buying and selling decisions in the most appropriate time in order to minimize risk and maximize profits.

Trend: The general direction of a market or of the price of an asset.

Resistance: A chart point or range that caps an increase in the level of a stock or index over a period of time.

Support: The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.

Breakout: A signal that prices are beginning to trend, either upward or downward.

Bull: An investor who thinks the market, a specific security or an industry is likely to rise.

Bear: An investor who thinks the market, a specific security or an industry is likely to decline.

Channel: is two parallel trend lines either rising or declining.

Consolidation Area: is a sideways movement in prices that interrupts or reverse a trend.

Moving Average (MA): The most common applications of MAs are to identify the trend direction and to determine support and resistance levels.

MACD (Moving Average Convergence-Divergence): A trend-following momentum indicator that shows the relationship between two moving averages of prices.

Relative Strength Index: A technical momentum indicator (ranges from 0 to 100) that compares the magnitude of recent gains to recent losses in an attempt to determine overbought and oversold conditions of an asset.

**Overbought:** A situation in which the price of a security has risen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.

**Oversold:** A situation in which the price of a security has fallen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors.

Fibonacci: A term refers to areas of support or resistance and to help identify strategic places for transactions to be placed, target prices or stop losses.

On Balance Volume (OBV): is a simple running total of up day (added) and down day (subtracted) volume. If OBV is moving with price, it confirms the current trend. Divergences between OBV and price indicates the price may be due for a reversal.
