

All Share Index <.BKA> closed at 4,897.43 point. A natural upward correction took place after the sharp drop since the start of the month. Additional strength cannot be ignored in an attempt to reach 5,130 point (38.2% level of the Fibonacci Retracements from 6,416 point-4,339 point), while a close above this could open the road for 5,375 point (50% level). On the negative side, the nearby support levels come at 4,825 point, 4,640 point and 4,510 point but only below 4,339 point will re-instate the bearish tone to 4,000 point.

Medium-term and long-term investors can only enter the market at levels higher than 5,760 point and 5,550 point, respectively.

Price closed at KWD0.748. The stock posted a temporarily low at KWD0.666, after falling from this year high at KWD1.061, before seeing some buying activity but it remains below all its MAs on the weekly chart. The next resistance level comes at KWD0.770, while above it will promote KWD0.825 and maybe KWD0.900. However, only losing the support level at KWD0.666 will deepen the bearish move to KWD0.625 before KWD0.580.

Price closed at KWD0.653. The stock recovered as it approached KWD0.500 (61.8% level of the Fibonacci Retracements from KWD0.297-KWD0.837). The challenge for the bulls is to surpass the resistance zone at KWD0.690-KWD0.717, which if happens will bring back to focus the high of this year at KWD0.837. On the counter side, the nearby support levels are located at KWD0.630 and KWD0.590 but only below KWD0.500 will change the tone.



Mobile Telecommunications Co. (ZAIN)

Price closed at KWD0.498. The overhead resistance level at KWD0.530 arrested additional gains, while managing to print a firm close above this will lead to KWD0.555 and maybe a re-test of the critical horizontal line at KWD0.603. However, a fall below KWD0.465 will trigger KWD0.435 and KWD0.407, but only below the last line will increase the downside risk and call for a slippage to KWD0.367.



Agility Public Warehousing Co.

Price closed at KWD0.552. The stock witnessed an aggressive move down from this year high at KWD0.860 before seeing an upward correction after the RSI indicators reached the oversold territory. Further gains can lead to KWD0.610, while a successful jump over it will promote KWD0.650. On the other side, a dip below the support level at KWD0.480 will most likely lead to KWD0.435 and maybe lower to KWD0.385.



Definitions

Technical Analysis: Aims to identify the direction of prices and reveal any indication of possible changes as soon as possible, so it can be used as much as possible in making buying and selling decisions in the most appropriate time in order to minimize risk and maximize profits.

Trend: The general direction of a market or of the price of an asset.

Resistance: A chart point or range that caps an increase in the level of a stock or index over a period of time.

Support: The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.

Breakout: A signal that prices are beginning to trend, either upward or downward.

Bull: An investor who thinks the market, a specific security or an industry is likely to rise.

Bear: An investor who thinks the market, a specific security or an industry is likely to decline.

Channel: is two parallel trend lines either rising or declining.

Consolidation Area: is a sideways movement in prices that interrupts or reverse a trend.

Moving Average (MA): The most common applications of MAs are to identify the trend direction and to determine support and resistance levels.

MACD (Moving Average Convergence-Divergence): A trend-following momentum indicator that shows the relationship between two moving averages of prices.

Relative Strength Index: A technical momentum indicator (ranges from 0 to 100) that compares the magnitude of recent gains to recent losses in an attempt to determine overbought and oversold conditions of an asset.

Overbought: A situation in which the price of a security has risen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.

Oversold: A situation in which the price of a security has fallen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors.

Fibonacci: A term refers to areas of support or resistance and to help identify strategic places for transactions to be placed, target prices or stop losses.

On Balance Volume (OBV): is a simple running total of up day (added) and down day (subtracted) volume. If OBV is moving with price, it confirms the current trend. Divergences between OBV and price indicates the price may be due for a reversal.
