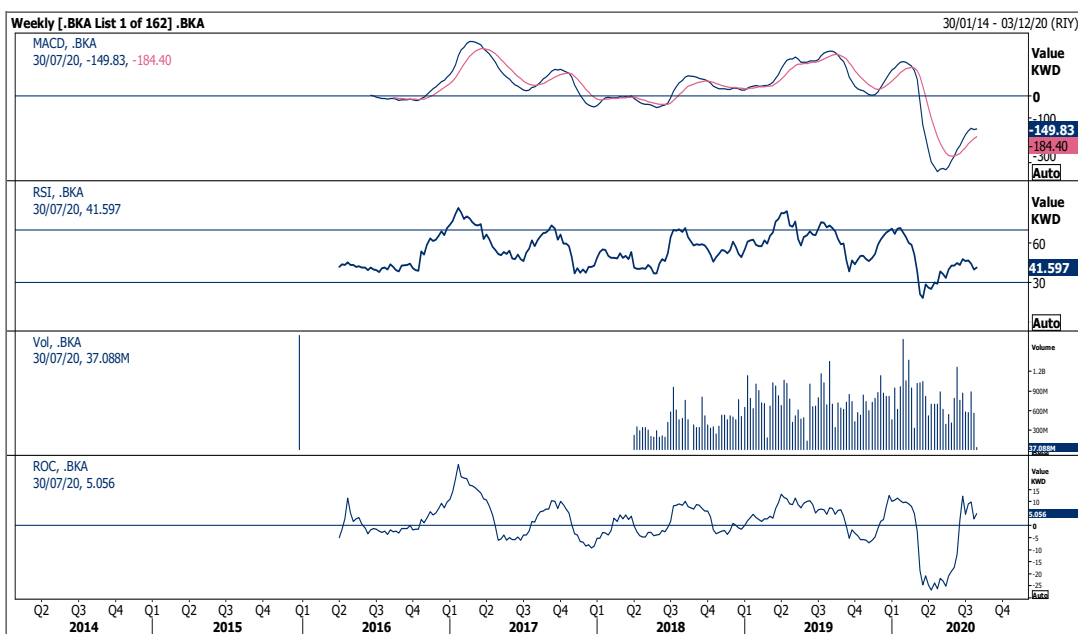
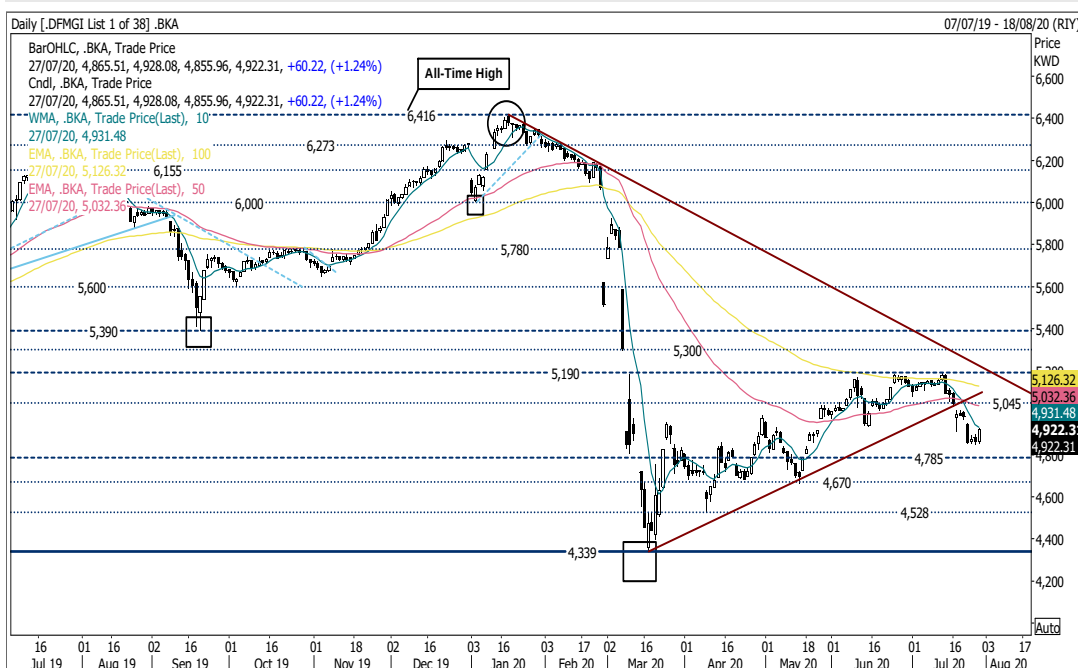

Boursa Kuwait

All Share Index <.BKA> closed at 4,922.31 point. The market looks steady after it found support at 4,855 point, which rejected additional weaknesses several times. A dip below this will re-instate the negative tone and lead to the next line of support at 4,785 point and maybe lower to 4,670 point. On the other side, the bulls need to surpass the resistance zone at 5,000 point-5,045 point to anticipate a jump to 5,190 point but it is necessary to print a foothold above this to decrease the downside risk and promote an advance to 5,390 point.

Medium-term and long-term investors can only enter the market at levels higher than 5,390 point.

Price closed at KWD0.533. The stock lost its upward momentum and fell below all MAs on the weekly chart, knowing that a break below the support level at KWD0.500 will call for a deeper bearish move to KWD0.450 and maybe to the low of this year at KWD0.407. However, re-gaining strength above KWD0.573 will target the strong layer at KWD0.603 but only a firm close above this will establish a new bull trend.

Price closed at KWD0.627. The stock did well after it recorded a low at KWD0.356, reaching a high at KWD0.690 before easing down. A fall below KWD0.600 would allow further losses to take place to KWD0.520 but a sharp downward move is not favored. On the counter side, a jump over KWD0.690 will confirm a re-test of this year high at around KWD0.748, while above this will confirm a gradual increase to KWD0.875.

Definitions

Technical Analysis: Aims to identify the direction of prices and reveal any indication of possible changes as soon as possible, so it can be used as much as possible in making buying and selling decisions in the most appropriate time in order to minimize risk and maximize profits.

Trend: The general direction of a market or of the price of an asset.

Resistance: A chart point or range that caps an increase in the level of a stock or index over a period of time.

Support: The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.

Breakout: A signal that prices are beginning to trend, either upward or downward.

Bull: An investor who thinks the market, a specific security or an industry is likely to rise.

Bear: An investor who thinks the market, a specific security or an industry is likely to decline.

Channel: is two parallel trend lines either rising or declining.

Consolidation Area: is a sideways movement in prices that interrupts or reverse a trend.

Moving Average (MA): The most common applications of MAs are to identify the trend direction and to determine support and resistance levels.

MACD (Moving Average Convergence-Divergence): A trend-following momentum indicator that shows the relationship between two moving averages of prices.

Relative Strength Index: A technical momentum indicator (ranges from 0 to 100) that compares the magnitude of recent gains to recent losses in an attempt to determine overbought and oversold conditions of an asset.

Overbought: A situation in which the price of a security has risen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.

Oversold: A situation in which the price of a security has fallen to such a degree that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors.

Fibonacci: A term refers to areas of support or resistance and to help identify strategic places for transactions to be placed, target prices or stop losses.

On Balance Volume (OBV): is a simple running total of up day (added) and down day (subtracted) volume. If OBV is moving with price, it confirms the current trend. Divergences between OBV and price indicates the price may be due for a reversal.
